1. Copy of South Dakota Sales Tax License
2. Business & Product Liability Certificate/Proof of Insurance (must be registered with 300 Cherapa Pl. Sioux Falls, SD 57103 with general and product liability insurance minimum of \$1 million dollars)
3. Copy of all state, city, and local permits and certifications required to sell vendor products
4. Non-refundable application fee of \$30 and **separate** payment for booth rental. Checks can be made payable to The Prairie Farmers Market. (Booth rental checks will not be cashed until application is approved)
